To All Whom These Presents May Concern:

I, Henry H. Lark SEND GREETINGS:

WHEREAS, I the said Henry H. Lark

in and by my certain promissory note, in writing, of even date with these presents, am well and truly indebted to WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION in the full and just sum of FORTY-FIVE HUNDRED and no/100--- (\$ 4,500.00) Dollars, with interest at the rate of six (6 %) per centum per annum, to be repaid in installments of
