WHEREAS, the Mortgagor is well and truly indebted unto TRAVELERS REST FEDERAL SAVINGS AND LOAN ASSOCIATION OF Travelers Rest, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Thousand Five Hundred and no/100

DOLLARS (\$ 6,500.00), with interest thereon from date at the rate of six and one-half per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Travelers Rest, S. C., being known as the greater portion of lot No. 25 on plat of property of John and Lynell Peterson, recorded in the R. M. C. Office for Greenville County in plat book PP at page 85, and having, according to said plat, the following metes and bounds, to-wit: 1/2

Beginning at an iron pin on the southwest side of Magnolia Street at the corner of lot No. 26 and running thence along the lines of lots Nos. 26 and 27, S 48-15 W, 150 feet to an iron pin; thence S 45-15 E, 90 feet to an iron pin in the line of lot No. 25; thence along the new line N 48-15 E, 150 feet to an iron pin on Magnolia Street; thence along Magnolia Street N 45-15 W, 90 feet to the point of beginning, and being a portion of that property conveyed to John and Lynell Peterson in deed book 464 at page 348 and deed of John Peterson conveying to Lynell Peterson his one-half interest in the above lot recorded in deed book 649 at page 234.
