TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Ladson J. Powell and Sara Jones Powell, of Greer, S. C., hereinafter called the Mortgagor, send (s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto RATTERREE-JAMES INSURANCE AGENCY

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Fourteen Thousand Dollars (\$ 14,000.00), with interest from date at the rate of Five & three-fourths per centum (5 3/4%) per annum until paid, said principal and interest being payable at the office of Ratterree-James Insurance Agency in Greer, S. C., or at such other place as the holder of the note may designate in writing, in monthly installments of Eighty-eight and 20/100 Dollars (\$ 88.20), commencing on the first day of September, 19 60, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of August, 19 85.

All that certain parcel or lot of land situated on the north side of Benjamin Avenue and the east side of Wood Drive, about one mile southward from the City of Greer, Chick Springs Township, Greenville County, State of South Carolina, and being Lot No. 30 of Brookhaven, plat thereof recorded in Plat Book RR, page 41, R.M.C. Office for Greenville County, and being particularly designated and shown as the Property of Ladson J. and Sara Jones Powell according to survey and plat thereof by John A. Simmons, R.S., dated June 6, 1960.
