All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 108 of a subdivision known as Orchard Acres, Section Two, as shown on a plat of a portion of said subdivision prepared by J. Mac Richardson, Surveyor, March, 1960, and recorded in the R. M. C. office for Greenville County in Plat Book QQ, at page 6, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Orchard Drive, joint front corner of Lots Nos. 107 and 108, and running thence with the joint line of said lots, S. 64-45 E. 210.7 feet to an iron pin in the line of Lot No. 160; thence with the line of Lot No. 160 and continuing with the line of Lot No. 159, N. 25-15 E. 84.7 feet to an iron pin, joint rear corner of Lots Nos. 108 and 157; thence with the joint line of said lots, N. 64-45 W. 177.3 feet to an iron pin on the eastern side of Orchard Drive; thence with said drive, S. 45-20 W. 90 feet to the beginning corner; being the same conveyed to me by Greenville Land Co., Inc. by deed of even date, to be recorded herewith.
