To ALL WHOM THESE PRESENTS MAY CONCERN: BUDDY C. PATTERSON, by Shirley M. Patterson, his Attorney in fact of Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 5 on plat of L. O. Bayne property made by J. C. Hill October 1958 recorded in the RMC Office for Greenville County, S. C., in plat book SS page 101, said lot having a frontage of 92 feet on the northwest side of Rainbow Drive, a depth of 164.1 feet on the northwest side, a depth of 150.4 feet on the northeast side and a rear width of 95 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
