Stiller, his heirs and assigns forever,

ALL that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, being known and designated as Lot No. 6 as shown on plat of property of Clara Bates Turner according to Survey made by Dean C. Edens, May 22, 1950 and having the following metes and bounds, to wit:
