**HAROLD H. ANTHONY** of  
**GREENVILLE, SOUTH CAROLINA**, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto  
**THE WESTERN AND SOUTHERN LIFE INSURANCE COMPANY**

, a corporation organized and existing under the laws of **STATE OF OHIO**, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of **Eleven Thousand Two Hundred Dollars (\$ 11,200.00 )**, with interest from date at the rate of **five & three-fourths** centum (**5 3/4**) per annum until paid, said principal and interest being payable at the office of **THE WESTERN & SOUTHERN LIFE INSURANCE COMPANY** in **ASHEVILLE, NORTH CAROLINA**, or at such other place as the holder of the note may designate in writing, in monthly installments of **Sixty-five and 41/100** ----- Dollars (\$ **65.41** ), commencing on the first day of **September**, 19 **60**, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of **August**, 19 **90**.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **GREENVILLE**, State of South Carolina:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the southern side of Cole Road, near the City of Greenville, being shown as Lot 9 on plat of property of W. H. Brown recorded in Plat Book 00, Page 117, and described as follows:

BEGINNING at an iron pin on the southern side of Cole Road 899.7 feet west from White Horse Road at the corner of Lot 10 and running thence with the southern side of Cole Road N. 86-45 W. 80 feet to an iron pin at the corner of Lot 8; thence with the line of said lot S. 9-45 E. 303.6 feet to an iron pin; thence N. 77-48 E. 65 feet to an iron pin at corner of Lot 10; thence with the line of said lot N. 7-06 W. 282.9 feet to the beginning corner.
