WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand Five Hundred and No/100

DOLLARS (\$ 7,500.00), with interest thereon from date at the rate of Six and One-Half per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township, being known and designated as Lot No. 22 in accordance with plat made for S. T. Holland dated October 14, 1949 by J. Q. Bruce, said Plat being recorded in Plat Book "W", Page 103 in the R.M.C. Office for Greenville County, and being more fully described in accordance with said Plat, to-wit:

BEGINNING at an iron pin on the western side of Jonesville Road (S.C. Highway 417) joint front corner of Lots Nos. 21 and 22 and running thence along Lot No. 21 S. 0-37 W. 24 feet to iron pin; thence S. 51-30 W. 217 feet to iron pin; thence S. 36-26 E. 279 feet to iron pin; thence N. 51-30 E. 217 feet to iron pin; thence S. 77-06 E. 46 feet to iron pin on Jonesville Road; thence N. 39-06 W. 325 feet to iron pin, being the point of beginning.
