NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the North-Western side of Jonesville Road in Austin Township, and having according to a plat recorded in Plat Book Y at page 15, the following courses and distances:

BEGINNING at an iron pin on the Northwestern side of Jonesville Road, at the corner of property now or formerly by Knight, and running thence with the Northwestern side of Jonesville Road, N. 41-12 E. 338.8 feet to pin at corner of property conveyed to D. T. Green, Sr., by deed recorded in Deed Book 587 at page 254; thence with the line of the Green property, N. 63-45 W. 450 feet, more or less, to an iron pin; thence S. 80-14 W. 300.4 feet to pin at corner of Knight property; thence with the line of Knight property, S. 49-08 E. 655 feet to the point of Beginning.

Being the same property conveyed to Mortgagors by two separate deeds, recorded in Deed Book 584 at page 212 and Deed Book 616 at page 339, respectively.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
