Dollars, to be paid \$50.00 on principal plus interest on Wednesday of each week commencing Wednesday, August 17, 1960, and continuing for a period of 26 weeks, at which time there shall then be due and payable the amount of \$100.00 plus interest on Wednesday of each week thereafter

, with interest thereon from date at the rate of 7 per centum per annum, to be computed and paid weekly

until paid in full; all interest not paid when due to bear
