"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the northern side of Perry Avenue and being designated as Lot 4 on plat of McBee Estates recorded in Plat Book K, Page 117, in the R. M. C. Office for Greenville County and being further described as follows:

BEGINNING at an iron pin on the northeastern side of Perry Avenue the joint front corner of Lots 3 and 4 which pin is situate 120 feet in a westerly direction from the intersection of Perry Avenue and an unnamed street, and running thence along the line of Lot 3 N. 19-05 E. 175 feet to an iron pin corner of Lot 38; thence with the line of Lot 37 N. 71-00 W. 60 feet to an iron pin corner of Lot 5; thence with the line of Lot 5 S. 19-05 W. 175 feet to an iron pin on the northern side of Perry Avenue; thence with the northern side of Perry Avenue S. 71-00 E. 60 feet to the beginning corner.
