All that certain parcel or lot of land situated at the northwest intersection of Littlefield Street and East Poinsett Street in the City of Greer, Greenville County, State of South Carolina, and being Lot No. 20 of the Estates of David and Pertima Cannon according to survey and plat by R.E.
