TO ALL WHOM THESE PRESENTS MAY CONCERN:

WOOTEN CORPORATION OF WILMINGTON, (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twelve Thousand and No/100ths-----

DOLLARS (\$ 12,000.00 ) , with interest thereon from date at the rate of six-----  
per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,  
**September 1, 1970**

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 2 as shown on a plat prepared by Dalton & Neves, Engineers, dated July, 1960, entitled "Property of Wooten Corp. of Wilmington" recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book UU at page 54, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Washington Boulevard at the joint front corner of Lots Nos. 1 and 2, which iron pin is 141.8 feet in a Northerly direction from the Northeastern corner of the intersection of Washington Boulevard and Nichol Street, and running thence with the Eastern side of Washington Boulevard N. 31-56 W. 18 feet to an iron pin; thence continuing with the Eastern side of Washington Boulevard N. 22-10 W. 49.4 feet to an iron pin; thence still continuing with the Eastern side of Washington Boulevard N. 17-49 W. 48.9 feet to an iron pin; thence with the curve of the intersection of Washington Boulevard and an unnamed street, the chord of which is N. 21-48 E., 42.3 feet to an iron pin on the Southern side of said unnamed street; thence with the Southern side of said unnamed street N. 61-25 E. 48 feet to an iron pin; thence S. 17-19 E. 150.2 feet to an iron pin at the joint rear corner of Lots Nos. 1 and 2; thence with the line of Lot No. 1 S. 65-0 W. 66 feet to the point of beginning.

This is a portion of the property conveyed to the mortgagor herein by deed of Fairforest Estates, dated April 25, 1960, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Deed Book 651 at page 101.
