MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Luther Alexander, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Three Thousand, Five Hundred and No/100 - (\$3,500.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Sixty-Eight and 49/100 - - - - - - - - - (\$ 68.49 ) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

extended, will be due and payable 5 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, on the northern side of Lee Road, containing 1 acre, more or less, and having, according to a survey made by J. Earle Freeman in 1936 and also according to a deed description recorded in Deed Vol. 516, at page 425, the following metes and bounds, to-wit:

"BEGINNING at an iron pin at the fork of Pine Knoll Drive, formerly known as McCarter Road and Lee Road, near the Camp Sevier Monument and south of the Southern Railroad right-of-way, and running thence N. 74-1/2 E. 3.84 chains, more or less, to an iron pin at the corner of property now or formerly of C. J. Combs; and running thence along the line of property now or formerly of C. J. Combs in the approximate direction of S. 14-38 W. 190 feet, more or less, to an iron pin on the northern side of said Lee Road at the joint corner of property now or formerly belonging to C. J. Combs; and running thence with the northern side of said Lee Road, N. 74-1/4 W. 1.28 chains, more or less, to a point in the curvature of the intersection of said Pine Knoll Drive and Lee Road; thence continuing still with said Lee Road, N. 41-1/2 W. 2.31 chains to the point of beginning; being a portion of the same property conveyed to me by Edna R. Evans by her deed dated September 22, 1950 and recorded in the R. M. C. office for Greenville County in Deed Vol. 419, at page 365."

The above described property is all of that property described in the deed from Edna R. Evans, less a portion of said property conveyed by me to C. J. Combs on January 13, 1955 and recorded in Deed Vol. 516, at page 425.
