TO ALL WHOM THESE PRESENTS MAY CONCERN: Edward R. Bolton and Sylvia W.

Bolton, of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

, a corporation
organized and existing under the laws of **South Carolina**, hereinafter
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which
are incorporated herein by reference, in the principal sum of **Fifteen thousand, one hundred & no/100**
Dollars (\$15,100.00-), with interest from date at the rate of **five & three-fourths** per centum
(5 3/4%) per annum until paid, said principal and interest being payable at the office of
C. Douglas Wilson & Co., in **Greenville, South Carolina**,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Ninety-five and 13/100-----Dollars (\$95.13-----),
