on the North side of Potomac Avenue, in the City of Greenville, in Green-
ville County, S.C., being shown as Lot 152 on plat of Pleasant Valley,
made by Dalton & Neves, Engineers, April 1946, recorded in the RMC Office
for Greenville County, S.C. in Plat Book P, at Page 93, said lot fronting
60 feet along the North side of Potomac Avenue and running back to a depth
of 160 feet on the East side, to a depth of 160 feet on the West side, and
being 60 feet across the rear.
