Smith Property prepared by W.J. Riddle, dated July 17, 1939, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book I at page 144, and having according to a more recent plat prepared by R.W. Dalton, dated June, 1957, entitled "Property of J. Charles Burns", the following metes and bounds:
