Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

extended, will be due and payable 20 years after date. NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

BEGINNING at an iron pin on the northerly side of Heathwood Circle at a point 282.9 feet west of the northwesterly corner of the intersection of Heathwood Circle and Heathwood Drive, said pin being the joint front corner of Lots 67 and 68, and running thence with the joint line of said lots, N. 20-43 E. 167 feet to an iron pin; thence N. 69-17 W. 25 feet to an iron pin; thence N. 70-16 W. 202 feet to an iron pin, joint rear corner of Lots 68 and 69; thence along the joint line of said lots, S. 21-09 E. 230 feet to an iron pin on the northerly side of Heathwood Circle; thence along the northerly side of Heathwood Circle on a curve, the chord of which is S. 76-20 E. 78 feet to the point of beginning; being the same property conveyed to us by R. M. Gaffney, et al. by deed dated August 2, 1960 and recorded in the R. M. C. Office for Greenville County in Deed Volume 658, Page 117.
