"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the east side of Buncombe Road and on the west side of Williams Street near the City of Greenville, and having according to a survey made in October of 1950, by Dalton & Neves, Engineers, the following courses and distances, to-wit:

BEGINNING at an iron pin at the northeast corner of the intersection of Buncombe Road and Morris Street (formerly known as mammett Street) and running thence along the east side of Buncombe Road, N. 18-04 E. 239 feet to a drill mark on wall on the east side of Buncombe Road; thence along line of property of Cone Mills Corporation, S. 72-05 E. 203 feet to an iron pin on the west side of Williams Street; thence along the west side of Williams Street, S. 18-24 W. 239 feet to a stake at the northwest corner of the intersection of Morris Street and Williams Street; thence with the north side of Morris Street, N. 72-05 W. 201.8 feet to the beginning corner.
