on the Western side of Hollywood Circle, in the City of Greenville, being shown as Lots Nos. 18 and 19 on Plat of Hollywood Subdivision recorded in Plat Book S, at page 37, and described as follows:

BEGINNING at an iron pin on the Western side of Hollywood Circle, at the corner of Lot No. 17, and running thence with the Western side of said Circle, N. 14-30 W. 113 feet to an iron pin at the corner of Lot No. 20; thence with the line of said lot, S. 75-30 W. 122.8 feet to an iron pin; thence S. 4-45 E. 114.7 feet to an iron pin at the corner of Lot No. 17; thence with the line of said lot, N. 75-30 E. 142.2 feet to the beginning corner.
