WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of  
Forty-five Hundred -----

DOLLARS (\$ 45 00.00 ), with interest thereon from date at the rate of Six & one-half per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Carolina Avenue in the City of Greer, Greenville County, and being Lot No. 21 of Development No. 2, Victor Monaghan Company, Division of J.P. Stevens & Co., Inc., Greer Plant, by Dalton & Neves, Engineers, April, 1947, recorded in Flat Book "P", page 119, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at an iron pin on the southern side of Carolina Avenue at the joint front corner of Lots Nos. 20 and 21, and running thence along the common line of said lots, S. 35-21 W. 170 feet to an iron pin on the northern side of a 10-foot alley; thence along the northern side of said alley, S. 54-39 E. 105 feet to an iron pin at the joint rear corner of Lots Nos. 21 and 22; thence along the common line of said last mentioned lots, N. 35-21 E. 170 feet to an iron pin on the southern side of Carolina Avenue, at the joint front corner of said last mentioned lots; thence along the southern side of Carolina Avenue, S. 54-39 W. 105 feet to an iron pin, the beginning corner.
