Addymanin and by MY certain promissory note, in writing, of even date with these presents, am well and truly indebted to WOODRUFF FEDERAL SAVINGS AND LOAN ASSOCIATION in the full and just sum of TEN THOUSAND NINE HUNDRED and no/100--- (\$ 10,900.00) Dollars, with interest at the rate of six (6 %) per centum per annum, to be repaid in installments ofNinety-one and 99/100--- (\$ 91.99) Dollars upon the first day of each and every calendar month hereafter until the full principal sum, with interest, has been paid.
