"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the **southeastern side of Mills Avenue in the City of Greenville, being shown as Lot 39 on a plat of Langley Heights recorded in Plat Book N, Page 133, and described as follows:**

BEGINNING at an iron pin on the southeastern side of Mills Avenue 252.6 feet northeast from Edgewood Drive at the corner of Lot 40 and running thence with the line of said lot S. 50-43 E. 169 feet to an iron pin on an alley; thence with the northwestern side of said alley N. 46-47 E. 50.43 feet to an iron pin at the corner of Lot 38; thence with the line of said lot N. 50-43 W. 175.6 feet to an iron pin on Mills Avenue; thence with the southeastern side of said avenue S. 39-17 W. 50 feet to the beginning corner.
