NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of **Greenville**, State of South Carolina:

All that lot of land situate, lying and being in Greenville County, State of South Carolina, at the western corner of Tanglewood Drive, and Old Easley Bridge Road, being shown as lot # 11-A on a revised plat of lot # 11 of Section 2 of Tanglewood, recorded in Plat Book DD at Page 52, RMC Office for Greenville County, and described as follows:

BEGINNING at a stake at the western corner of Old Easley Bridge Road, and Tanglewood Drive, and running thence with the north-western side of Old Easley Bridge Road, S. 59-05 W. 82 feet to a stake; thence N. 66-03 W. 132.3 feet to a stake at the corner of lot # 11-B; thence with the line of said lot, N. 59-05 E. 158.1 feet to a stake on Tanglewood Drive; thence with the southwestern side of said Drive, S. 30-55 E. 108.1 feet to the beginning corner.

Being the same premises conveyed to the mortgagors by The Independent Life & Accident Insurance Company by deed to be recorded.

Together with all and singular the rights, members hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
