WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Green, Chick Springs Township, being known and designated as Lot No. 62 on plat of Development No. 2, Victor-Monaghan Company, Division of J.P. Stevens & Co., Inc., Green Plant, prepared by Dalton & Neves Engineers, April, 1947, and recorded in the R.M.C. Office for Greenville County in Plat Book P, at page 119, having according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the south side of Maryland Avenue, joint corner of Lots Nos. 61 and 62, and running thence along the common line of said lots, S. 35-21 W. 296.6 feet to a point on the right-of-way on the main line of the Piedmont and Northern Railway Company; thence S. 77-22 E. 119,2 feet to a point at the joint rear corner of Lots Nos. 62 and 63; thence along the common line of said lots, N. 35-21 E. 250.6 feet to a point on the south side of Maryland Avenue; thence along the south side of Maryland Avenue, N. 54-39 W. 110 feet to the beginning corner.
