WHEREAS, the Mortgagor is well and truly indebted unto

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

ALL that lot of land with the buildings and improvements thereon, situate
on the Northeast side of Sunset Drive, in the City of Greenville, in
Greenville County, S.C., being shown as Lot No. 67 on Plat 2 of Sunset
Hills, made by Dalton & Neves, Engineers, December 1945, recorded in the
RMC Office for Greenville County, S.C. in Plat Book P, Pages 18 and 19,
said lot fronting 75 feet along the Northeast side of Sunset Drive, and
running back to a depth of 175 feet on the Southeast side, to a depth of
175 feet on the Northwest side, and being 75 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
