WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-one Hundred and No/100 -----

DOLLARS (\$ 4100.00), with interest thereon from date at the rate of six and one-half (6½%) per centum per annum, said principal and interest to be repaid in monthly instalments of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, lying on the west side of a County Road, in Little Texas Community, and bounded by lands of James Keeler, W. J. I. Edwards and other land of P. M. Johnson, containing 0.41 acre, more or less, and having the following metes and bounds:

BEGINNING at an angle iron, formerly a persimmon, corner for lands of P. M. Johnson, Keeler and Edwards, and running thence S. 43 W. 200 feet to iron pin; thence W. 42 W. 90 feet to iron pin; thence N. 43 E. 200 feet over iron pin on west bank of road to point in Edwards line in road; thence S. 42 E. 90 feet to the beginning corner.
