# MORTGAGE WITH

TO ALL WHOM THESE PRESENTS MAY CONCERN:

Chester A. MacMillan and Helen J. MacMillan of  
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

General Mortgage Co.

, a corporation  
, hereinafter  
organized and existing under the laws of South Carolina  
called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which  
are incorporated herein by reference, in the principal sum of fourteen thousand, eight hundred  
Dollars (\$ 14,850.00 ), with interest from date at the rate of five and 3/4 per centum fifty  
(5 3/4) per annum until paid, said principal and interest being payable at the office of  
General Mortgage Co. in Greenville, South Carolina,  
or at such other place as the holder of the note may designate in writing, in monthly installments of  
ninety-three and 56/100 Dollars (\$ 93.56 ),  
commencing on the first day of December, 19 60, and on the first day of each month there-

if not sooner paid, shall be due and payable on the first day of November, 19 85.

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville,  
State of South Carolina:

All that piece, parcel or lot of land situate in Gantt Township,  
Greenville County, South Carolina, and being known and designated as Lot  
16 on a plat entitled South Forest Estates, made by Pickell and  
Pickell, Engineers, August 29, 1955, and recorded in the R. M. C.  
Office for Greenville County in Plat Book GG, at page 181.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
