NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Lowndes Hill Road, in Butler Township, being shown and designated as Lot 2 and a portion of Lots 3 and 4 and 5 on plat of the property of C. F. Putman, recorded in Plat Book II, Page 139, and the portion of Lots 3, 4 and 5 are also shown as Lot 6 on plat of the property of C. F. Putman recorded in Plat Book SS, Page 31, and having according to said plats the following metes and bounds, to-wit:
