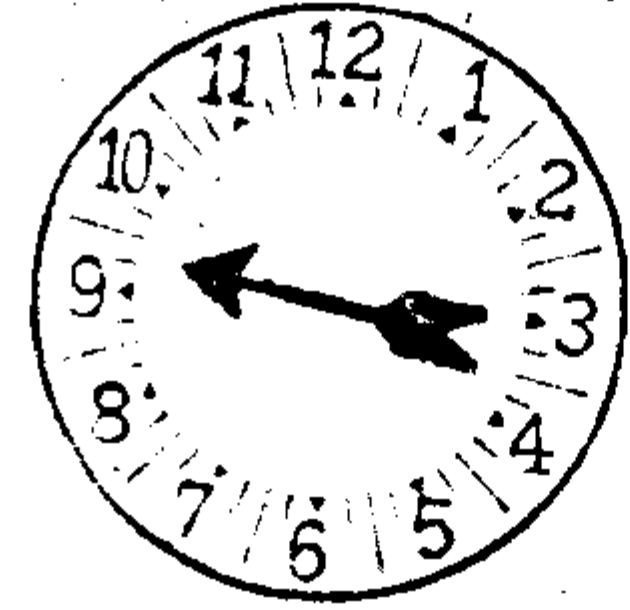

BEGINNING at old stone near branch, Caldwell Corner running thence S. 70-30 W. 300 feet to stake; thence N. 5-20 W. 343 feet to stake; thence S. 83-49 E. 1010 ? feet to point at road; thence with, or about with road S. 16-04W. 453.3 feet (old iron pin reference at S. 51-03 E. 9.4 feet); thence N. 61-03 W. 631.6 feet to the BEGINNING.
