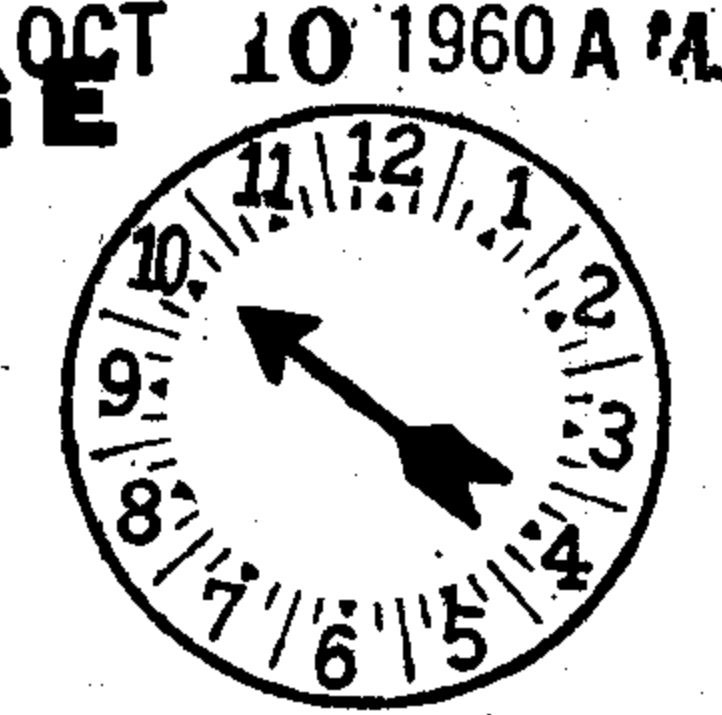

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released; and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

*BEGINNING at a corner of Billy Campbells' land and running with Campbell's line South 72 3/4 W. about 85 yards to the road; thence with the line of the road North about 200 yards to Crowell Pittman home tract; thence with his home place line Northeast about 114 yards to an iron pin in R. E. McClure's line; thence with McClure's line South 41 E. 390 feet to an iron pin; thence continuing with McClure's line east about 85 yards to McClure's and Campbell's corner; thence with Campbell's line about 160 yards to the beginning containing five acres more or less.*
