NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the northeastern corner of Allen Street and Whitin Street, near the City of Greenville, being shown as Lot 62 of Section 2, on a plat of Dunean Mills Village recorded in Plat Book S, Page 175, and described as follows:

BEGINNING at an iron pin at the northeastern corner of Allen Street and Whitin Street and running thence with the northern side of Whitin Street S. 64-15 E. 141.7 feet to an iron pin on an alley; thence with western side of said alley N. 22-50 W. 84.5 feet to an iron pin at the corner of Lot 63; thence with the line of said lot N. 64-15 W. 149.7 feet to an iron pin on Allen Street; thence with the eastern side of said street S. 25-52 E. 84.5 feet to the beginning corner.
