with interest from **date** at the rate of **six (6)** per centum per annum until paid; interest to be computed and paid **monthly** and if unpaid when due to bear interest at same rate as principal until paid, and **I** have further promised and agreed to pay ten per cent of the whole amount due for attorney's fee, if said note be collected by attorney or through legal proceedings of any kind, reference being thereunto had will more fully appear.

All my right, title and interest (the same being a one-third undivided interest) in and to:

All that piece, parcel, lot or tract of land lying, situate and being in the City of Greenville, State and County aforesaid, described as follows:

BEGINNING at an iron pin on the East side of North Main Street, which iron pin is 165.1 feet in a southerly direction from the southeast intersection of North Main Street and Elford Street, and running thence S. 68-40 E. 291.5 feet to the north edge of a cement post in the line of North Brown Street; thence along the western side of North Brown Street S. 29-30 W. 89.5 feet to the center of a pier; thence along the northern side of a brick wall now or formerly owned by Greenville Hotel Co. N. 68-55 W. 274.1 feet to the north edge of the wall in line of North Main Street; thence along the eastern side of North Main Street N. 18-07 E. 90 feet to an iron pin, the point of beginning.
