All that piece, parcel, lot or tract of land lying, situate and being in the City of Greenville, State and County aforesaid, described as follows:

BEGINNING at an iron pin on the East side of North Main Street, which iron pin is 165.1 feet in a southerly direction from the southeast intersection of North Main Street and Elford Street, and running thence S. 68-40 E. 291.5 feet to the north edge of a cement post in the line of North Brown Street; thence along the western side of North Brown Street S. 29-30 W. 89.5 feet to the center of a pier; thence along the northern side of a brick wall now or formerly owned by Greenville Hotel Co.
