WHEREAS, the Mortgagor is well and truly indebted unto **Aiken Loan & Security Company**

, a corporation  
organized and existing under the laws of **South Carolina**, hereinafter

and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of **Greenville**,

All that lot of land in the county of **Greenville**, state of **South Carolina**, at the southwest corner of the intersection of **Conway Drive**
