The real estate herein released is described as follows:

All that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, on the southeastern side of Pinckney Street and lying between Pinckney Street and a railroad spur and being part of the property of John H. Langley as shown on plat thereof prepared by Piedmont Engineering Service dated September 1960 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Pinckney Street in the center line of the railroad spur right-of-way in the point where said spur crosses Pinckney Street and running thence along the center line of said roadroad spur N. 41-20 E. 27.8 feet; N. 47-15 E. 50 feet; N. 55-50 E. 55 feet; N. 66-33 E. 50 feet; N. 68-56 E. 65 feet to a point; thence N. 48-39 W. 163.5 feet to a point on the southeastern side of Pinckney Street; thence along the curve on the right-of-way along the southeastern side of Pinckney Street to the point of beginning, the traverse courses and distances being S. 28-13 W. 176.5 feet to an iron pin; S. 1-24 W. 82.5 feet to the point of beginning.
