NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Tucson Drive, near the City of Greenville, shown as Lot No. 99 on a plat of Western Hills, Sections 1 and 2 recorded in Plat Book QQ, Page 98-99, being more particularly described as follows:

BEGINNING at an iron pin on the southern side of Tucson Drive at the front corner of Lot 100; thence with the line of said lot S. 16-43 E. 174.1 feet to an iron pin in therear line of Lot 76; thence with the rear line of Lots 76 and 77 N. 73-30 E. 100 feet to an iron pin at the rear corner of Lot 98; thence with the line of said lot N. 16-43 W. 174.4 feet to an iron pin on the southern side of Tucson Drive; thence with the southern side of said drive S. 73-17 W. 100 feet to the beginning.
