sum of FIVE THOUSAND and no/100--- (\$ 5,000.00) Dollars,

with interest at the rate of six (6) per centum per annum, to be repaid in installments of

Fifty and no/100--- (\$ 50.00) Dollars upon the first

day of each and every calendar month hereafter until the full principal sum, with interest, has been paid.
