of land situate, lying and being in Greenville County, South Carolina, and being
shown as Lot No. 9, 10, & 11 on the plat of property of C. H. Branyon, and
having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Washington Street
Extension at the joint front corner of Lots 8 and 9, as shown on said plat, and
running thence N. 52-26 E., 136.3 feet to an iron pin on the western edge of
Lot No. 4; thence with the line of Lot No. 4 S. 26-36 E., 110.6 feet to an iron
pin; thence S. 15-36 W., 144 feet to an iron pin on the eastern side of Washington
