All that certain piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina on the northwestern side of Duncan Bridge Road, also known as Watkins Bridge Road, being shown and designated as Lot 2, property of L. Hugh Merck and Doris Good Merck, on a plat prepared by Dalton & Neves, October, 1960, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwest side of Duncan Bridge Road, said iron pin being 1003.5 feet from the northwest corner of intersection of Duncan Chapel Road and Duncan Bridge Road, and running thence with the line of the property of James D. Kincaid, N. 52-25 W. 276.5 feet to an iron pin in the line of Oakland Terrace Subdivision; thence with the line of said subdivision S. 41-15 W. 144.8 feet to an iron pin; thence S. 53-25 E. 285.6 feet to an iron pin on the northwest side of Duncan Bridge Road; thence with said road, N. 37-35 E. 139.4 feet to the beginning corner.
