To ALL WHOM THESE PRESENTS MAY CONCERN: I, James R. Echols

Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings: of

WHEREAS, the Mortgagor is well and truly indebted unto General Mortgage Co.,

organized and existing under the laws of South Carolina, a corporation hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Sixteen Thousand Six Hundred Dollars (\$ 16,600.00 ), with interest from date at the rate of five & three/100ths ( 5 3/10%) per annum until paid, said principal and interest being payable at the office of General Mortgage Co. in Greenville, South Carolina or at such other place as the holder of the note may designate in writing, in monthly installments of Ninety Six and 94/100 ----- Dollars (\$ 96.94 ), commencing on the first day of January, 19 61, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of December, 19 60.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

ALL THAT CERTAIN piece, parcel or lot of land, situate, lying and being on the easterly side of Stratford Road, near the City of Greenville, in Gantt Township, being shown and designated as Lot No. Eighty Five (85) of South Forest Estates on a plat thereof made by Pickell & Pickell, Engineers, August 29, 1955, and recorded in the R.M.C. Office of Greenville County, South Carolina, in Plat Book "GG", at Page 181, reference to which is craved for a more complete description thereof.

This lot runs a total of 100 feet along the eastern side of Stratford Road; runs 127.7 feet along its northern side; runs 132.6 feet along its southern side; and is 80.3 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
