"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on Augusta Road, in the City of Greenville, being known and designated as Lot 13, Block N, of the O. P. Mills Property, according to a plat thereof recorded in Plat Book C at Page 176, in the R. M. C. Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

"HEGINNING at an iron pipe on the western side of Augusta Road, 204 feet from the southwest corner of Augusta Road and Grove Road; thence along line of Lot 12, S. 42-53 W. 179.85 feet to an iron pipe on rear line; thence along rear line of lots, S. 47-52 E. 68 feet to an iron pipe, corner of Lot 14; thence along line of Lot 14, N. 42-53 E. 179.9 feet to an iron pipe on the western side of Augusta Road; thence N. 47-57 W. 68 feet to the point of beginning."
