SEND GREETINGS:

"BEGINNING at an iron pin on the eastern side of Garrett Street, joint front corner of Lots 22 and 23; thence with the eastern side of said Garrett Street; No 9-06 E. 100 feet to the intersection of said Garrett Street with an unnamed street; thence with the southern side of said unnamed street, S. 80-30 E. 192,5 feet to an iron pin, the joint corner of Lots Nos. 23 and 40; thence with the line of Lot 40, S. 8-30 W. 100 feet to an iron pin, joint rear corner of Lots 22 and 23; thence with the joint line of said lots, N. 80-30 W. 184 feet to the point of beginning; being one of the lots conveyed to me by Melvin K.
