MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, L. C. Craig, of Greenville County,

SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Eleven Thousand and No/100 - - - - - (\$ 11,000.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Eighty-Three and 40/100 - - - - - (\$ 83.40) Dollars upon the first day of

each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal bal-

ances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently extended, will be due and payable 18 years after date. The note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty (30) days, or failure to comply with any of the By-Laws of said Association, or any of the stipulations of this mortgage, the whole amount due under said note, shall, at the option of the holder, become immediately due and payable, and the holder may sue thereon and foreclose this mortgage; said note further providing for ten (10%) per centum attorney's fee beside all costs and expenses of collection, to be added to the amount due on said note, and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by said note, reference being thereunto had, will more fully appear.

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 18 of a subdivision known as Pinehurst, Section 2, according to a plat thereof prepared by J. Mac Richardson, R. L. S., March, 1960 and recorded in the R. M. C. office for Greenville County in Plat Book MM, at page 153, and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the northeastern side of Vista Drive in the subdivision property line, the front corner of Lot No. 18, and running thence along the subdivision property line, N. 24-32 E. 177.7 feet to an iron pin; thence along the rear line of Lot No. 18, S. 53-30 E. 122.7 feet to an iron pin, the joint rear corner of Lots 18 and 19; thence along the joint line of said lots, S. 36-30 W. 157.4 feet to an iron pin in the turn around on the northeastern side of said Vista Drive, joint front corner of Lots 18 and 19; thence with the curvature of the turn around of Vista Drive, the chord of which is N. 41-08 W. 34.9 feet; thence continuing still with the curvature of said turn around, the chord of which is N. 87-33 W. 43.9 feet to an iron pin; thence with the northeastern side of said Vista Drive, N. 53-30 W. 14.8 feet to the point of beginning; being the same conveyed to me by W. E. Shaw as Trustee for W. E. Shaw and W. N. Leslie by deed dated December 5, 1960, to be recorded herewith."

The mortgagor also conveys all his right, title and interest in and to that portion of the turn around on Vista Drive which shall revert and become a part of Lot No. 18 when and if the 50-foot street known as Vista Drive is extended and the turn around abandoned.
