C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the Old Georgis Road, being shown as the 1.85 acre tract "For B. C. Henderson" on plat of property of B. F. Henderson, prepared August, 1951, by W.J. Riddle, recorded in the R. M.
