C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Twenty-Five Thousand and No/100------

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the northern side of Mountain View Avenue, in the City of Greenville, being shown as lots # 18 and 18A of Section A on a plat of Buist Circle, recorded in Plat Book C at Page 10, and as revised recorded in Plat Book HH at Page 17, and described as follows:

BEGINNING at an iron pin on the northern side of Mountain View Avenue, 250 feet west from Townes Street and running thence N. 9-12 E. 232.2 feet to iron pin on Orange Street; thence with the southern side of said Street, N. 72-19 W. 100.6 feet to iron pin, corner of lot # 17; thence with the line of said lot, S. 9-26 W. 246 feet to iron pin on Mountain View Avenue; thence with the northern side of said Avenue, S. 80-15 E. 100 feet to the beginning corner.
