NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, On the northern side of Pettigru Street, being known and designated as Lot 3, Block 10, Boyce Lawn Addition, recorded in Plat Book A, at Page 179, and described as follows:

BEGINNING at an iron pin on the northern side of Pettigru Street 138 feet 4 inches from Boyce Avenue, at the corner of Lot 2, and running thence along line of said lot N. 15-00 W. 126 feet 1 inch to iron pin in line of a 10 foot alley; thence along the southern side of said alley N. 76-45 E. 66 feet 8 inches to iron pin at the corner of Lot 4; thence with the line of said lot S. 15-00 E. 126 feet 1 inch to iron pin in Pettigru Street; thence with the northern side of said street S. 76-45 W. 66 feet 8 inches to the beginning.
