Dollars (\$ 6950.00), with interest from date at the rate of five & 1/4 per centum (54 %) per annum until paid, said principal and interest being payable at the office of the Loan Guaranty Officer, Veterans Administration Regional Office, at Columbia, South Carolina, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Forty-six and 84/100 Dollars), commencing on the 5th day of February , 1961, day of each month thereafter until the principal and interest day of February and continuing on the 5th are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and day of January payable on the 5th ., 19.81.

Now, Know All Mrn, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagoe, and unto his successors in such office, as such, and his or their assigns, the following described property, to-wit:

-All that lot of land in Austin Township, county of Greenville, state of South Carolina, on the northwest side of Log Shoals Road, and having according to a recent survey made by C. O. Riddle, December 13, 1960 the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the northwest side of Log Shoals Road, at the corner of property now or formerly belonging to Elizabeth Putman; thence with the line of said property N. 55-30 W. 173 feet to an iron pin corner of W. D. Roberts property; thence with the line of said property N. 29-50 E. 100 feet to an iron pin; thence S. 55-30 E. 173 feet to an iron pin on the northwest side of Log Shoals Road; thence with the northwest side of said road S. 29-50 W. 100 feet to the beginning corner.
