SEND GREETINGS:

VILLE, in the full and just sum of Nine Thousand One Hundred and No/100 - - 75 9.100.00)
Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of

Sixty-Five and 20/100 - - - - - (\$ 65.20) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

M. C. Office for Greenville County in Plat Book QQ, at page 35, and according to said plat being more particularly described as follows:

"BEGINNING at an iron pin on the southeastern side of Birch Court at the front corner of Lot 16, and running thence with the line of said lot, S. 50-05 E. 318.6 feet (erroneously indicated on the plat as 218.6 feet) to the center line of a branch, passing through an iron pin 15 feet from said branch; thence with the said branch as the line, the traverse line of which is N. 29-32 E. 127.1 feet to a point in the center line of said branch, the rear corner of Lot 14; thence with the line of said lot, N. 50-05 W. 295.7 feet (passing through iron pin 15 feet from said branch) to an iron pin on the southeastern side of Birch Court; thence with the southeastern side of Birch Court, S. 39-55 W. 125 feet to the beginning corner; being the same conveyed to the mortgagor corporation by J.
