Loren G. Avra (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Six Thousand and no/100----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the Southern side of Williams Drive, near the City of Greenville, Greenville County, shown as Lot 52 on a plat of Orderest Park, recorded in Plat Book S at page 109, more particularly described as follows:

BEGINNING at an iron pin on the southern side of Williams Drive, at the front corner of Lot 51; thence with the line of said lot, S. 8-16 E. 140 feet to an iron pin on the North side of a 20 foot alley; thence with the Northern side of said alley, S. 81-44 W. 80 feet to an iron pin at the rear corner of Lot 53; thence with the line of said lot, N. 8-16 W. 140 feet to an iron pin on the South Side of Williams Drive; thence with the South side of said Drive, N. 81-44 E. 80 feet to the Beginning.
